THE AUTHORITY HEREUNDER DOES NOT EXTEND TO DPDs WHERE THE REPRODUCTION AND DISTRIBUTION OF A PHONORECORD (OR THE MUSICAL WORK) IS INCIDENTAL TO THE TRANSMISSION WHICH CONSTITUTES THE DPD.
